AGREEMENT DATED JANUARY 25, 1956
BETWEEN RAILROADS REPRESENTED BY THE
EASTERN, WESTERN AND SOUTHEASTERN
CARRIERS' CONFERENCE COMMITTEES
AND THEIR EMPLOYEES
REPRESENTED BY THE
RAILROAD YARDMASTERS OF AMERICA

A G R E E M E N T

This Agreement made this 25th day of January, 1956, by and between the participating carriers listed in Exhibits A, B and C, attached hereto and made a part hereof, and represented by the Eastern, Western and Southeastern Carriers' Conference Committees, and the employees shown thereon represented by the Railroad Yardmasters of America, through its Conference Committee, witnesseth:

IT IS AGREED:

ARTICLE I

(a) Effective October 1, 1955, basic monthly rates of pay for all employees covered by this agreement shall be increased by \$26.20, such increase to be added to the basic monthly rates in effect September 30, 1955.

(b) Also effective October 1, 1955, basic monthly rates of pay for all employees covered by this agreement shall be increased by an additional \$6.80, such increase to be added to the basic monthly rates in effect September 30, 1955. This additional increase of \$6.80 per month is in lieu of a medical and hospital plan for employees represented by the Railroad Yardmasters of America. If the aforesaid organization desires to move for a carrier-financed health and welfare plan for yardmasters, this additional wage increase of \$6.80 per month or such portion thereof as may be required under a plan adopted by mutual agreement will be automatically converted for payment of such health and welfare plan as may be adopted.

(c) Also effective October 1, 1955, basic monthly rates of pay for all employees covered by this agreement shall be increased by a further additional \$10.00, such further additional increase to be added to the basic monthly rates in effect September 30, 1955. This further additional increase of \$10.00 per month is made with the full understanding and agreement that such amount will become and will be applied as a part of the conversion factor in the event that the Railroad Yardmasters of America desire to place the entire craft or class of yardmasters on a five-day work week on all carriers upon which that organization represents yardmasters.

(d) In the application of the monthly wage increases provided in paragraphs (a), (b) and (c) of this Article I:


(1) The daily rate shall be determined by multiplying the monthly rate by 12 and dividing by 261.

(2) The straight time hourly rate shall be determined by dividing the monthly rate by 174.


NOTES:

- 1: Yardmasters rates of pay on this property were increased \$21.00 per month, effective January 1, 1956. Such increase will be cancelled as of its effective date and will be replaced by the terms of this agreement.
 - 2: Authorization does not include General Yardmasters at Shoreham, Minnesota, Superior, Wisconsin and Schiller Park, Illinois.
 - 3: Authorization does not cover positions of General Yardmasters.
 - 4: Authorization does not include positions of General Yardmasters at Texarkana, Dallas, and Fort Worth.
 - 5: Authorization is limited to the classes of yardmasters included in the Agreement with the Railroad Yardmasters of America, namely, Assistant General Yardmasters, Yardmasters and Assistant Yardmasters, including Tower Yardmasters.
 - 6: Authorization does not include one (1) position of General Yardmaster at Decatur, which is not covered by the current schedule agreement; nor does authorization cover one position of General Yardmaster at Detroit, Montpelier, Toledo, Fort Wayne, Peru, Tilton, Chicago, Springfield, Hannibal, Kansas City, Moberly, Vandeventer (St. Louis), Luther-St. Louis Ave., (St. Louis) and Brooklyn (East St. Louis) positions which are subject only to Articles 1, 4(c) and 4(d) of current schedule agreement.
 - 7: Authorization covers Yardmasters and Assistant Yardmasters.




